**Application for annual or temporary
credentials or hunter's permit**

INTRASTATE FOR-HIRE - Motor Carriers operating only within Missouri (intrastate commerce) must purchase and display Missouri intrastate stickers.

INTRASTATE AND INTERSTATE – Motor Carriers operating in interstate commerce as well as in intrastate commerce may include their intrastate vehicles when renewing their **Unified Carrier Registration (UCR)** and are not required to purchase and display the sticker.

- If you do not include vehicles operating only within Missouri in the total vehicle count for UCR or your company is not required to file an UCR application, you must complete the B-1R Annual/Temporary Credential renewal and purchase the intrastate stickers for those vehicles.

INTRASTATE RENEWAL – Review the pre-printed information. If your address has changed, please line through the incorrect address and write the new address to the right.

- In order to receive your renewal credentials by January 1, 2009, submit your renewal **prior to November 15, 2008**.
- Stickers are valid from January 1 to December 31.

TYPE OF CREDENTIALS:

- **Intrastate Passenger Service – Sticker (Window Stickers)** – Passenger operations operating solely within Missouri whose vehicle(s) have a seating capacity of 6 to 12 passengers.
- **Intrastate Operations – Sticker (Door Decal)** - Property and passenger operations. Passenger Operations with a seating capacity 6 to 12 passenger capacity).
- **72-Hour Combined Reciprocity and Motor Fuel Permit** - Required when the carrier is based in another jurisdiction and traveling in Missouri but not properly registered with Missouri or under International Fuel Tax Agreement. Enter the number of combined fuel and reciprocity permits needed.
- **72-Hour Permit** – This trip permit takes the place of a stamp or sticker. The permit does not take the place of required authority.
- **72-Hour Reciprocity Permit** –Required when based in another jurisdiction and traveling in Missouri but not properly registered with Missouri. Permit must be obtained prior to entry into Missouri.
- **72-Hour Motor Fuel Permit** – Required when based in another jurisdiction and when traveling in Missouri but not registered under IFTA. Must be obtained prior to entry into Missouri. Missouri carriers not licensed with IFTA and operating a qualified vehicle interstate must obtain this permit prior to re-entering Missouri.
- **30-Day Hunter's (Unladen) Permit** – Authorizes the movement of a vehicle and trailer in all International Registration Plan jurisdictions upon cancellation of a lease, at the empty weight by a lessor if the apportioned plate has been surrendered to the (motor carrier) lessee.

Be sure to total the fees. Make checks payable to "Director of Revenue". Staple the check to the form.

Sign the form. Remember to include your job title (owner, president, etc.)
